ENDURING RELATIONSHIPS, LASTING IMPACT

A deep sense of belonging, coupled with earnest striving to unfold individual and shared potential, is central to the Plowshare experience. These essential qualities and Plowshare's work are bigger than any one of us. Their importance will live on beyond the journey of a single lifetime.

Have you considered making a planned gift to Plowshare Farm as part of your estate planning?

A **planned gift** can bring expression to your enduring support for the Plowshare community and the shared values we embody long into the future.

- Planned giving is for everyone – every gift, large or small, makes a difference.
- Planned giving is a lasting and meaningful way to express your deepest values.
- Planned giving strengthens the causes you care about – planting seeds that will bear fruit for generations to come.

WAYS TO CREATE A LEGACY

Bequests and Wills

A bequest through your will or living trust can help you make a more significant gift to Plowshare than you might during your lifetime. Plowshare can be named to receive a percentage, a dollar amount, or the remainder of your estate after other commitments have been fulfilled.

Beneficiary Designations

Beneficiary designations offer a simple way to gift assets such as retirement plans and life insurance policies tax-free after death. This involves filling out a simple form with your financial institution, making it an easy way to give.

IRA Charitable Rollovers

If you are 70 ½ years old and up, you can gift up to \$100,000/year from an IRA directly to Plowshare tax-free.

While a planned gift can be simple to arrange, we hope you will seek the advice of your professional advisors to determine the best options for you.

SAMPLE BEQUEST LANGUAGE

Below is some sample bequest language for consideration and discussion with your attorney/advisors:

"I hereby give, devise and bequeath [“the sum of __” or “__ percent of my estate” or “the following asset(s): _____” or “the remainder of my estate”] to Plowshare Farm, Inc., a nonprofit organization located at 32 Whitney Drive, Greenfield, NH 03047, Federal Tax ID #23-2315224, for Plowshare Farm’s general use and purpose."

If you would like to make a restricted bequest, specifically to support people's choice to continue calling Plowshare home regardless of future changes to state and federal funding or a family's financial circumstances, please be in touch with us and we will be happy to work with you and your attorney on language that fulfills this intention.

Plowshare Farm is a 501(c)(3) nonprofit organization recognized by the IRS. Contributions are tax-deductible to the extent provided by law.
